*ARTICLE IV, SECTION V: Delinquent Dues. When dues of a member are not paid to the Association within thirty (30) days after the due date, such dues shall become delinquent.

MEMBERSHIP CATEGORIES

- Active (Continuing) Member:** Dues for an active member of this Association shall be \$25 per year, plus \$20 per capita tax to LSI for total of \$45.
- New Member:** Seeking active status granted by vote of the Executive Board, payment of \$25 SCCoLPA annual dues, plus \$20 per capita tax to LSI, plus \$10 initiation fee (one-time only), for a total of \$55.
- Associate Member:** Candidates with less than one year in a law-related environment. Dues for an associate member of this Association shall be \$15 per year, plus \$20 per capita taxes to LSI, plus \$10 initiation fee (one-time only), for a total of \$45.
- Retired Member:** Age 62, retired from employment, wishing to retain active status:
 A. Less than 10 years in SCCoLPA, payment of \$20 LSI per capita taxes.
 B. More than 10 years in SCCoLPA, no payment.
- Disabled Member:** Must present certification of permanent disability and wishing to retain active status:
 A. Less than 10 years in SCCoLPA, payment of \$20 LSI per capita taxes.
 B. More than 10 years in SCCoLPA, no payment.
- Life Member:** Granted upon vote of the members to any member who has performed outstanding services to the Association. If a life member desires to retain active membership status, full payment of dues is required.
- Delinquent Dues:** When dues are not paid to the Association within thirty (30) days after the due date, such dues shall become delinquent, and such member shall without notice be suspended and shall lose all rights and privileges as a member of this Association. Such suspended member may be reinstated during the current fiscal year upon payment of the current annual dues, plus a reinstatement fee of \$5.
